A Guide to Use Classes Order in England

With effect from 1st September 2020

The Town and Country Planning (Use Classes)(Amendment)(England) Regulations 2020 (SI 2020 No.757) amended the Town and Country Planning (Uses Classes) Order 1987. The new classes formally came into force in England on 1 September 2020. Consequently, The Town and Country Planning (General Permitted Development etc.) (England)(Amendment)(No. 2) Order 2021 (SI 2021 No. 814) amended the Town and Country Planning (General Permitted Development)(England) Order 2015.


Class Description

Sui Generis Includes, but is not restricted to: amusement centres, betting offices/shops, bingo hall, casinos, cinemas, concert halls, dance hall, fuel stations, swimming pools; the hiring, selling and/or display of motor vehicles; hostels, hot food takeaways (where the consumption is mostly undertaken off the premises); public houses, wine bars and drinking establishments; launderettes, live music venues, taxi firms, theatres, HMO's for greater than six persons.
